This month Dr. Heather Baker, EdD patient representative told her story to AHA Staff and the impact it had on her.

"As a school principal with published research regarding cardiac emergency preparedness in schools, I have volunteered alongside the AHA's Midwest Advocacy team to help pass a law in Illinois that requires cardiac emergency response plans in all schools, and will be working hard to pass this law in other states as well.

It was an honor to speak to the AHA Science and Research staff. As a sudden cardiac arrest survivor, I have personally been impacted by the research funded by and the guidelines published by the AHA, through my own personal medical care. Having a son with a congenital heart defect, I have watched medical decisions for him be guided by the AHA's guidelines. As a Survivor and school principal whose SCA happened at school, I advocate for cardiac emergency response plans, CPR/AED training in schools and communities, and better ways to screen for cardiac conditions. The science published by this department is critical for moving towards being a society in which individuals no longer needlessly die from sudden cardiac arrest and other heart conditions: a society in which everyone is prepared to respond to a cardiac emergency.

My goal in speaking to this group was for my story to serve as a reminder that their hard work, research, and publications determine the fate of people like me and my son all over the world. Again, I am grateful to have had the opportunity to share my story and to hopefully inspire the team!"

The proposal must focus on the collaborative relationship, such that the scientific objectives cannot be achieved without the efforts of at least two co-principal investigators and their respective disciplines.

This initiative will support a collaborative network of researchers whose collective efforts will address critical questions and stimulate significant advances in our understanding of Cardiovascular Kidney Metabolic (CKM) Syndrome in women and the related contributing factors. CKM Syndrome is a health disorder due of connections among heart disease, kidney disease, diabetes and obesity. Health outcomes are poor and affect multiple organ systems, and the considerable heterogeneity seen in CKM is not well understood. Outcomes from the SFRN should facilitate improved approaches for both prevention and treatment of CKM.
